Build your deck with Trex Elevations® Steel Deck Framing and we'll up the labor coverage to five years. This protection also ensures that an authorized TrexPro Platinum or TrexPro Gold contractor will restore your deck.

## 2-YEAR LIMITED RESIDENTIAL LABOR WARRANTY OPTION

Purchase Trex Transcend decking or porch flooring and Trex will cover 100% of the labor cost for warranty replacement for two years beyond the project completion date.

## 5-YEAR LIMITED RESIDENTIAL LABOR WARRANTY OPTION

Use Trex Elevations Steel Deck Framing as your supporting structure and receive a total of five years of protection on Transcend decking boards or porch planks.

- » Covers labor on Transcend decking and porch flooring only
- » Decking, porch flooring and framing must be installed by a TrexPro Platinum or TrexPro Gold contractor
- » Contractor must register labor warranty within 30 days of project completion date
- » Labor warranty can be transferred once

No matter which you choose, your Transcend deck and porch materials are automatically covered by the Trex 25-Year Limited Residential Warranty and 25-Year Limited Residential Fade and Stain Warranty





## TrexPro® Platinum & TrexPro Gold TREX TRANSCEND® LIMITED RESIDENTIAL LABOR WARRANTY

Trex Company, Inc. (hereinafter "Trex") warrants to the holder of this labor warranty ("Owner"), that for a period of two (2) years from the date of final installation, or five (5) years from the date of final installation if the Trex Elevations® steel deck framing system is used, if a breach of warranty occurs with respect to the Owner's Trex Transcend® decking board or porch plank product under either the Trex Limited Warranty or the Trex Limited Fade and Stain Warranty (the "Warranties"), and provided that a TrexPro® Gold or Platinum contractor installed the deck and properly registered the Warranties, Trex will pay for all reasonable labor expenses in replacing the defective material.

This labor warranty only covers residential installations.

This labor warranty does not apply to Trex Transcend railing or fascia.

This labor warranty only covers labor associated with the replacement of defective Trex Transcend decking board or porch plank product. It does not cover labor associated with the replacement of any other defective Trex product.

This labor warranty may be transferred one (1) time, within the five (5) year period beginning from the date of original purchase by Owner, to a subsequent buyer of the property upon which the Product was originally installed.

To make a claim under this labor warranty, Owner shall send to Trex, within the warranty period referred to above, a description of the claimed defect and proof of purchase to the following address:

Upon confirmation by an authorized Trex representative of a defect covered by the Trex Limited Warranty and/or the Trex Limited Fade and Stain Warranty, as the case may be, the prior registration of Owner's Warranties and compliance with all other terms of this labor warranty, Trex shall (1) replace the product under the terms of the applicable Warranty, and (2) arrange for a local TrexPro® contractor to replace the defective material, at Trex's cost.

This labor warranty may not be altered or amended except in a written instrument signed by Trex and Owner.

UNDER NO CIRCUMSTANCES WILL TREX BE LIABLE FOR ANY COST OTHER THAN LABOR COSTS TO REPLACE DEFECTIVE TREX MATERIAL. TREX SHALL NOT BE RESPONSIBLE FOR ANY OTHER SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES, WHETHER SUCH DAMAGES ARE SOUGHT IN CONTRACT, IN TORT (INCLUDING BUT NOT LIMITED TO NEGLIGENCE AND STRICT LIABILITY) OR OTHERWISE.



This warranty shall only be applicable and enforceable in the United States of America and Canada.
